The world's economic, political, and legal systems are built to serve the interests of the rich and powerful, mostly in the Global North. Acknowledging this, GLAN works to develop innovative litigation strategies to use the law *for good*. In collaboration with civil society groups, activists, and affected communities around the world, we develop bold legal strategies that cross borders to challenge impunity, shift power, and uphold human rights and environmental justice.

What will you support?

By joining the Justice Network you'll play a vital part in our work and help:

- Bring innovative climate litigation to ensure states do their fair share before it's too late
- Tackle deforestation and the profit-driven destruction of vital ecosystems like the Amazon rainforest
- Build on our historic win to stop the import of goods produced through forced labour and help clean up more international supply chains
- Support legal strategies to stop land grabs and protect community rights in the Caribbean
- Seek accountability for war crimes and defend international law.

How much do I need to give?

Whatever works for you. The Justice Network starts from as little as £1 a month, and whether you give £5 or £500, you're an equal part of it.

Where does my money go?

Your contribution fuels the legal strategies, investigations and community partnerships behind our work.

What are the benefits of joining the Justice Network?

Can I claim Gift Aid?

Yes! UK Taxpayers can add 25% to their donation at no extra cost.

How often will donations be taken from my account?

GLAN's regular donations are taken once a month.

Because our cases often take years to pursue, your support also provides the long-term funding we need to take on complex, high-impact cases and stand with communities until justice is achieved.
